The Bank of Canada unveiled a Commemorative \$10.00 Bank Note to mark the 150th anniversary of Confederation. Bank of Canada Governor Stephen S. Poloz and Parliamentary Secretary to the Minister of Finance Ginette Petipas Taylor revealed the new note in a ceremony at the Bank's head office in Ottawa.

The [Canada 150](#) Bank Note celebrates Confederation with a unique design depicting Canada's history, culture and land. It offers a number of security features, some new and others that are similar to those on the current series of polymer notes. These features make the Bank Note easy to check and difficult to counterfeit.

This limited-issue Commemorative note will circulate along with the existing \$10.00 note. It will be available to Canadians through their financial institutions starting on June 1, 2017.
